- \*Reminder: Supervisor Pernice reminded the Board that a Public Hearing on the 2014 Budget will be held on Thursday, November 14, 2013 at 6:00 PM.
- \*Water / Sewer Rate Increases: There was discussion on the proposed increases in water and sewer rates. A motion was made by Supervisor Pernice and Deputy Supervisor Enslow to increase water \$5.00 per quarter and increase sewer \$10.00 per quarter. All in Favor Carried

#### **COUNCIL COMMENTS**

\*Councilman Harvey asked Officer Trimm how come Office Scott Rogers was not on the current schedule. Officer Trimm stated that he is currently on his way back from vacation and he is scheduled to cover court and do grant work. Councilman Harvey also asked how the Resource Officer Program is going at school. Officer Trimm stated the program is working well. There was discussion. All Officers have had a tour of the school and they are working inside and outside of school at different hours.

### **APPROVE PAYMENT OF BILLS**

A motion was made by Councilman Harvey and Deputy Supervisor Enslow to approve payment of bills #171-186 in the amount of \$23,593.40 for the Highway Abstract and bills #600-660 in the amount of \$68,688.83 for the Regular Abstract. All in Favor – Carried
