The Norfolk Town Board held a monthly meeting on Wednesday, February 13, 2019 at 07:00 PM at the Norfolk Town Hall.

Present were Supervisor Charles Pernice, Deputy Supervisor Robert Harvey, Councilman Donald Purvis, Councilwoman Jean Gang and Councilman Paul Paige.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was said by all present.

CALL MEETING TO ORDER

Supervisor Pernice called the meeting to order.

APPROVAL OF MINUTES

The minutes of the January 09, 2019 Town Board meeting were reviewed and approved as submitted with a motion by Councilwoman Gang and Councilman Paige. All in Favor – Carried

SUPERVISOR'S UPDATE

Supervisor Pernice noted that there is another water leak in Raymondville.

REPORTS

*Monthly Police Report: The monthly report of Police Officer in Charge Dan Holmes was reviewed and approved as submitted with a motion by Councilman Purvis and Councilwoman Gang. All in Favor – Carried

Officer Holmes stated that the background check on Tyler Reynolds was all good. Councilman Purvis and Councilman Paige made a motion to hire Tyler Reynolds as a part time Police Officer. All in Favor – Carried

Officer Holmes also noted that the computers in the Police office have been updated and are not crashing anymore.

*Monthly Code Enforcement Report: The monthly report of CEO Leonard Halpern was reviewed and approved as submitted with a motion by Councilman Paige and Councilman Purvis. All in Favor – Carried

Councilman Paige asked CEO Halpern about the McGregor property on Marsh Road. CEO Halpern noted that it had been burned out a couple of years ago and she has replaced it moving the trailer back on the lot a few feet. There was discussion.

Councilwoman Gang asked CEO Halpern about the rescheduling of the Smith property case in Town Court. CEO Halpern noted that the Attorneys have rescheduled the case until February 20th. There was discussion.

*4th Quarter Rescue Squad Report: The 4th Quarter Report of the Norfolk Rescue Squad was reviewed and approved as submitted with a motion by Councilman Paige and Councilman Purvis. All in Favor – Carried

*Verbal Highway Report: Supervisor Pernice noted that Highway Superintendent Peter Darabon was not present due to lack of sleep from

plowing all night. He also noted that there is another water leak. Supervisor Pernice updated the Board that the new screener is on its way. There was discussion. The cost was \$20,515.00.

*2019 Contract with NN Youth Basketball: The 2019 Contract with NN Youth Basketball in the amount of \$650.00, was reviewed and approved as submitted with a motion by Councilman Purvis and Councilwoman Gang. All in Favor – Carried

*Appoint Town Justice: A motion was made by Councilman Paige and Councilwoman Gang to approve the appointment of Stephanie Wilcox as Town Justice. All in Favor – Carried

Town Justice George Grubee will finish out this month for salary. Town Justice Wilcox will attend training in April.

*Resignation: A motion was made by Deputy Supervisor Harvey and Councilwoman Gang to accept the resignation of Officer Cory Williams from the Police Department. All in Favor – Carried
