CALL MEETING TO ORDER

Supervisor Pernice called the meeting to order at 6:30pm (immediately following the completion of the preceding 2021 Budget Public Hearing).

APPROVAL OF MINUTES

*Monthly Police Report: The monthly report of the Norfolk Police Department was reviewed and approved as submitted with a motion by Councilwoman Gang and Deputy Supervisor Harvey. Supervisor Pernice noted that DCO Jim McConkey would be taking some time off for medical reasons and that he was getting his son trained so that he could fill in until he was able to return to work.

*Monthly Court Report: There was no monthly court report.

Supervisor Pernice noted that an advertisement had been placed and there was at least one person who had expressed interest in the open court clerk position. He requested that the board allow the hiring process to proceed as quickly as possible if a qualified candidate were found and approve the hiring now rather than wait unit the next board meeting. There was agreement to this.

*Verbal Highway Report: Highway Superintendent Peter Darabon gave the following updates:

- The town trucks are all ready for winter.
- A section of sewer line on Sober Street had to be replaced. Work is complete.
- Finished helping the towns of Madrid and Waddington get their sand supplies ready for winter.
- We have a supply of rock dust from Barrett's that we will be mixing in with the sand/salt this winter in hopes that it will improve road treatment results.
- The 2012 Int'l truck is back down to Stadium (in Watertown) for repairs again. They are bringing in a specialist from Navistar to try to figure out what the cause of the problem is this time.

EXECUTIVE SESSION

Reduction of \$34.80 was for a scheduled insurance premium payment that was not needed due to the employee (Angus Ladue) passing away. All in Favor – Carried

*Resolution #21 of 2020: Ogdensburg Sales Tax Proposal – A motion was made by Councilman Purvis and Deputy Supervisor Harvey to adopt Resolution #21 of 2020 A Resolution to Support the City of Ogdensburg Proposed Change in the County Sales Tax Apportionment to Local Municipalites.
