# **Health Care Policy -**

#### Town Hall Boiler -

Supervisor asked the board for authorization to seek out quotes to have the old boiler in the basement of the Town Hall replaced due to the ever increasing costs associated of maintenance and repair.   - One (1) 6" water main break on Elm Circle was repaired
  - Blowers 1 & 2 are down again at the sewer plant. Discussions regarding the situation are being held with Aaron Jarvis (Tisdel Associates Engineer) to figure out how to reduce the excessive failure rate and high costs to repair/replace these pumps.
  - We will not be getting our customary Extreme Weather Recovery \$30,000 CHIPS money from the state this year.
