### WATER PROJECT UPDATE

Town Engineer Aaron Jarvis reviewed the Water Project to date and noted what will be done in the next few weeks. He reviewed bills submitted for payment as follows: Sheehan Contracting - \$90,012.50, Norwood Plumbing - \$2,945.00, Jordstat Const. Inc. - \$5951.64, Statewide Aquastore, Inc. - \$84,033.20, and Tisdel Associates - \$14,750.00. There was discussion.

\*Resignation of Russell Burnap: A motion was made by Councilwoman Gang and Councilman Purvis to accept the resignation of Russell Burnap from the Zoning Board of Appeals. All in Favor – Carried

\*Resolution #24 of 2012: Support home rule legislation to allow St. Lawrence County to consider a possible increase of sales tax. The Resolution was reviewed and adopted with a motion by Councilman Harvey and Councilman Purvis. All in Favor – Carried

\*Water / Sewer Relevies: Unpaid water and sewer for accounts still outstanding for 2011 and with nothing paid at all for 2012 in the amounts of \$76,041.50 for Water and \$47,014.00 for Sewer were approved to be relevied to the 2013 Town and County Taxes with a motion by Deputy Supervisor Enslow and Councilwoman Gang. All in Favor – Carried

\*Approve the 2013 Budget: A motion was made by Councilman Harvey and Supervisor Pernice to approve the 2013 Budget. All voted in favor except Deputy Supervisor Enslow voted no. Carried

## **COUNCIL COMMENTS**

\*Councilman Purvis asked Highway Superintendent Larry Villnave again if the County has scheduled the work on the

storm drains on West Main Street. There was discussion. Supervisor Pernice and Mr. Villnave will both contact the County on it.

\*Councilman Harvey noted that vehicles were traveling too fast on High Street on Halloween night. He had called Officer Trimm about the issue. Office Trimm noted that she is working on scheduling some more daytime hours.

# **APPROVE PAYMENT OF BILLS**

Bills #175 - 192 in the amount of \$32,266.48 for the Highway Abstract and bills #655 - 737 in the amount of \$164,274.50 for the Regular Abstract were approved for payment with a motion by Councilman Harvey and Deputy Supervisor Enslow. All in Favor - Carried
