#### SUPERVISOR'S UPDATE

- ➤ Darabon House (7 W Main St) Supervisor Pernice noted that this property has asbestos. The town has funds set in reserve for site preparation and he would like to move forward with this project.
  - Decision to get quotes for asbestos remediation on the house located at 7 W Main St was approved with a motion by Deputy Supervisor Molnar and Councilman Blair. All in Favor - Carried

- ➤ Raymondville & 420 Community Halls Supervisor Pernice noted that these two buildings are in need of attention. He suggested that the Board Members each take time to go take a look for themselves. There was discussion. No action taken.
- ➤ Bail Reform Supervisor Pernice asked that Town Justice Derek Stevenson give an update on what our local Justice Court is experiencing. Judge Stevenson noted that given the current laws, there is basically no good way to enforce the payment of fines for traffic violations and it's causing the loss of thousands of dollars that would otherwise be collected revenue.
